



**SECOND AMENDMENT TO THE
DECLARATION OF CONDOMINIUM
OF
RESIDENCES AT MIDTOWN, A CONDOMINIUM**

○ Article 6, Section 6.1, is here amended as follows:

- 6.1 By the Association. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is to be considered. A resolution for the adoption of a proposed amendment may be proposed either by a majority of the Board of Directors of the Association or by not less than one-third (1/3) of the voting interests of Units of the Association. Except as elsewhere provided, approvals must be by affirmative vote of:

Unit Owners in excess of ~~sixty six and two thirds (66 2/3%)~~ a majority of the Units in the Condominium and by not less than sixty-six and two-thirds (66 2/3%) percent of the Board of Directors of the Association; or

Unit Owners in excess of ~~seventy five (75%)~~ sixty-six and two-thirds (66 2/3%) percent of the Units in the Condominium.


